BUSING PROGRAM CONDITIONS

- Participation in BCS Busing services is contingent upon the child(ren)'s compliance with BCS School Bus Regulation. The Parent/Guardian acknowledges and agrees that the student must comply with BCS student code of conduct while being transported to and from school.
- Enrollment is NOT available on a monthly basis.
- Busing enrollment is by term.
 - Term 1: September December
 - Term 2: January March
 - Term 3: covers April June
- Once enrolled, parents are responsible for busing charges until the end of the term or subsequent terms.
- Once enrolled, BCS assumes enrollment in the busing program through to the end of the school year. Any
 withdrawals require a 1 month (30 day) notice using the Request to Cancel School Bus Transportation
 Form and withdrawal is effective at the beginning of the next busing term following the notice period. No
 refunds will be processed for service cancelled after April 30th.
- Notwithstanding the above provisions concerning refunds, if there are other fees or charges owing to BCS from the Parent/Guardian, BCS reserves the right to retain the refund for the purpose of deducting the amount of the refund from the outstanding charges or fees owed to BCS.
- The Parent/Guardian agrees that if the cheque or Pre-Authorized payment is dishonored for any reason, the Parent/Guardian shall be liable to pay BCS on demand, an NSF fee of \$50.00 in addition to the fee for busing service.
- BCS reserves the right to make operational changes to the schedule, specific stops and route in keeping with possible student additions or withdrawals as the year progresses.
- In the case where a student requires transportation service beginning mid-year, the month in which this registration is entered shall be prorated to the number of school bused days in that month.
