

Not Returning / Withdrawal Form

Bears paw Christian School operates on a continuous enrollment model, meaning current Kindergarten to Grade 11 students are automatically re-enrolled each year on **February 1st for the upcoming school year**.

- **Not Returning Withdrawal:** If your family **does not intend for a student(s) to return for the upcoming school year**, this form **must** be submitted to formally notify the school and initiate the withdrawal process. Submission of this form by the deadlines outlined on page 2 impact eligibility for refunds of certain fees, also outlined in your Financial Agreement.
- **In-Year Withdrawal:** If your family chooses to withdraw a student(s) **during the current school year**, please note that you remain financially responsible for the **full tuition for the remainder of the school year**, in accordance with the Financial Agreement, regardless of whether the student transfers to another school or to BCS@Home.
- **Future Readmission::** Families who withdraw and later wish for a student(s) to return to Bears paw Christian School will be required to re-apply and meet the admissions and financial requirements in effect at the time of reapplication. Readmission is subject to enrollment capacity and classroom availability.

Completion of this form is required to initiate the withdrawal process and ensure accurate student records.

In-Year Withdrawals (Current School Year)

A withdrawal submitted for a student transferring out of BCS **during** the current academic year is considered a **late withdrawal**.
